MASSACHUSETTS LABORERS' ANNUITY FUND

This is a summary of the annual report for the MASSACHUSETTS LABORERS' ANNUITY FUND, (Employer Identification No. 04-6553616, Plan No. 001) for the period July 1, 2008 to June 30, 2009. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$55,570,859. These expenses included \$2,920,623 in administrative expenses and \$52,650,236 in benefits paid to participants and beneficiaries. A total of 22,873 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$601,970,377 as of June 30, 2009 compared to \$730,665,733 as of July 1, 2008. During the plan year the plan experienced a decrease in its net assets of \$128,695,356. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$-73,124,497, including employer contributions of \$54,202,383, losses of \$45,220,609 from the sale of assets and earnings from investments of \$-82,106,271.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An accountant's report;
2. Financial information and information on payments to service providers;
3. Assets held for investment;
4. Transactions in excess of 5 percent of the plan assets; and
5. Information regarding any common or collective trust, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
